Directions to the Site:

From the West: Take I-90 to Exit 27 (Snouqualmie-North Bend). At stop sign, go left back under the freeway. Road curves to right and downhill. Go approx. 1.2 miles, watch for sign to Snouqualmie Falls and left turn lane shortly thereafter. Turn left at Meadowbrook Way (NOT well marked until after you turn). Continue across Railroad Ave (stop light at SR 202) and continue to Park St. (4-way stop). Turn right, go approx. 0.5 miles, past Snouqualmie Elementary School and Centennial Fields. First field is marked with large Meadowbrook Farm sign and there are two more fields further along on the right. Watch for Lure Trial signs.
From the East: Take I-90 to Exit 31. At end of off-ramp, go right onto SR 202. Stay on SR 202 (Bendigo Blvd.) as it crosses W North Bend Way and turns sharply left. After crossing the river, veer right onto Boalch Ave NW, and continue approx. 1 mile until you see the Lure Trial signs.

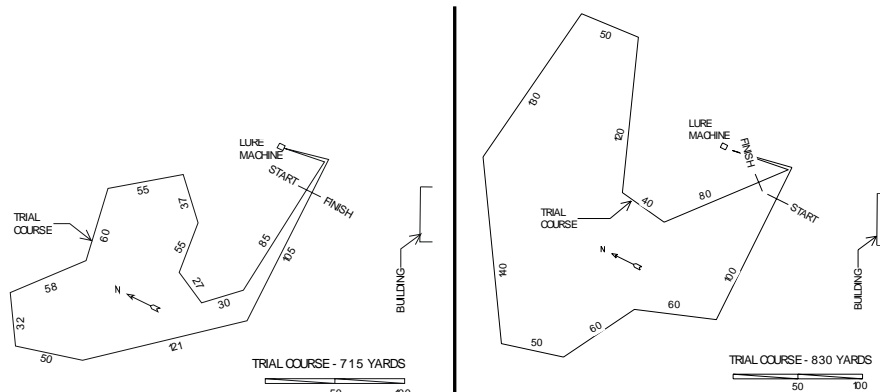
STAKES OFFERED

OPEN: Any eligible sighthound, excluding ASFA Field Champions of Record.
FIELD CHAMPION: Any ASFA Field Champion.
VETERAN: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Whippets whose age shall be at least seven years.
LIMITED: Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements.
SINGLES: Saturday only: Any eligible sighthound including those disqualified to run in other stakes. Points are not awarded. Hounds are not eligible to run in BOB or BIF.
BREEDER STAKE: Sunday only: For any two hounds, designated at time of entry, bred by the same person.
KENNEL STAKE: Sunday only: For any two hounds, designated at time of entry, owned and kenneled by the same person.
BEST IN FIELD (Saturday) AND BEST IN REGIONAL INVITATIONAL (Sunday) will be offered.

GENERAL

1. All entries must be one year of age or older on the day of the trial.
2. Stakes shall be split by public random draw if the entry in any one stake is 20 or more at the time of the draw.
3. In the Trial, all hounds will run twice, in trios if possible, or braces, unless excused, dismissed, or disqualified.
4. Hounds not present at the time of roll call will be scratched. Each entry will be examined at inspection for breed disqualifications, bitches in season, and lame hounds, which will be excused. Entry fees for hounds excused during inspection will be refunded. Spayed or neutered hounds without breed disqualifications may be entered.
5. **Certifications will be offered before the trial only on Saturday and by early entry only.**
6. Battery powered **continuous loop** machines will be used. Lure will consist of white plastic bags. The course will be reversed for the finals and run-offs. Backup equipment will be available.
7. The field committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
8. **THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE HOUNDS FROM THE TRIAL SITE.**
9. **THERE WILL BE A \$5.00 FINE ASSESSED FOR ANY LOOSE HOUND NOT TAKING PART IN THE COURSE IN PROGRESS, OR FOR ANYONE NOT PICKING UP AFTER THEIR OWN DOG(S). ALL TRASH, INCLUDING DOG FECES, MUST BE HAULED AWAY BY THE OWNER.**
10. **PLEASE BRING YOUR OWN SHADE AND WATER.**
11. **NO ONE, EXCEPT FIELD COMMITTEE, WILL BE ALLOWED ON THE FIELD WITHOUT EXPRESS PERMISSION OF THE FIELD CHAIRMAN.**
12. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
13. No cigarette smoking permitted on this working farm field.

Home Again Microchip, collar tag, pre-paid registration = \$20

Tattoo from B&B Tattooing = \$15

WHERE:

Meadowbrook Farm, North Bend

In conjunction with our May Lure Trial in the main building.

Directions: **From the West** -Take I-90 to Exit 27 (Snoqualmie/North Bend). At stop sign, go left back under the freeway. Road curves right and downhill. Go approx. 1.2 miles, watch for sign to Snoqualmie Falls and left turn lane shortly thereafter. Turn left at Meadowbrook Way. Continue across Railroad Ave (stop light at SR 202) and continue to Park St.(4-way stop). Turn right, go approx. 0.5 miles, past Snoqualmie Elementary School and Centennial Fields. Watch for lure trial signs. **From the East** - Take I-90 to Exit 31. At end of off-ramp, go right onto SR202. Stay on SR202 (Bendigo Blvd.) as it crosses W North Bend Way and turns sharply left. After crossing river, veer right onto Boalch Ave NW, and continue approx 1 mile until you see the Lure Trial signs.

WHAT TO BRING:

1. Puppies as young as 10 weeks and adults of any age
2. AKC registration numbers, AKC ILP numbers, existing microchip numbers
3. Your money; microchip fees payable prior to implant, tattoo pay in advance

WHY:

Every year dogs are turned in to rescue that have no traceable identification. Because your dog can lose their collar or have it removed, keeping non-removable ID on your pet at all times is critical. Microchips are great because they are small and any shelter or vet clinic can scan for the information and contact you or an alternate contact immediately. Tattoos add another mode of safety in that they can be seen by the rescuer in case the collar is lost or removed.
